As a result, the Server Board could be delivered to customers with any of the PBA shown in the "Products Affected" table.
2. Adding the UKCA and updating Canada logos in regulatory and packaging labels.

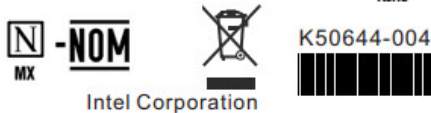

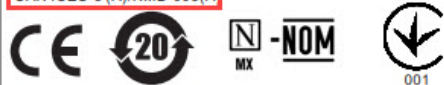
