## Description of Change to the Customer:

**Reason for Revision: Remove the following product codes (already RoHS compliant): FW4UCPSCSI, FWH4UFPSATA, FHW6UCPSCSI and FHW6UFPSATA. Change post change assembly numbers for FHW4UPDB, FHW4USCSIBP and FHW6UPDB.**

The common spares used with both the non RoHS compliant SHW4UR, SHW6UR server platforms and the RoHS complaint SHW4URM, SHW6URM servers platforms are transitioning to be aligned with the European Union legislation, which requires Restrictions on Hazardous Substances (RoHS) and bans lead (Pb) after July 1, 2006 unless covered in and exemption.

See PCN #105740-xx for SHW4UR and SH6UR transition to SHW4URM and SHW6URM.

If required, the Intel server spares described in this Product Change Notification will meet the Server Exemption, allowing leaded solder in the manufacturing process. The change to the accessories options will occur over a three month period listed in the Forecasted Key Milestones.

The process and component changes have no impact on product form, fit, function, or product reliability. Intel has successfully completed our standard suite of Functional and Qualification testing and has achieved eutectic equivalence.

### Customer Impact of Change and Recommended Action:

No significant impact on product/process/material performance, appearance, quality, reliability, interchangeability, functionality or customer handling and manufacturability.
