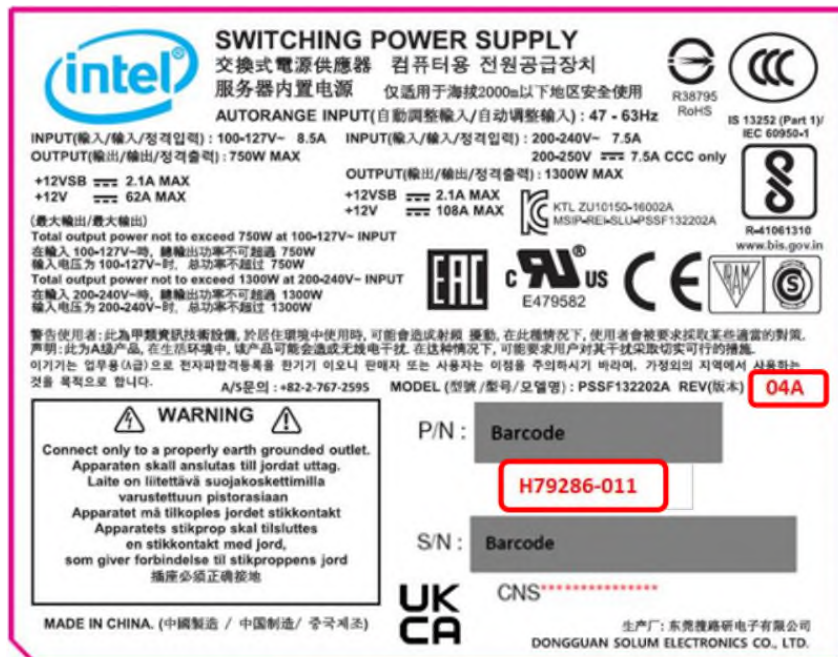

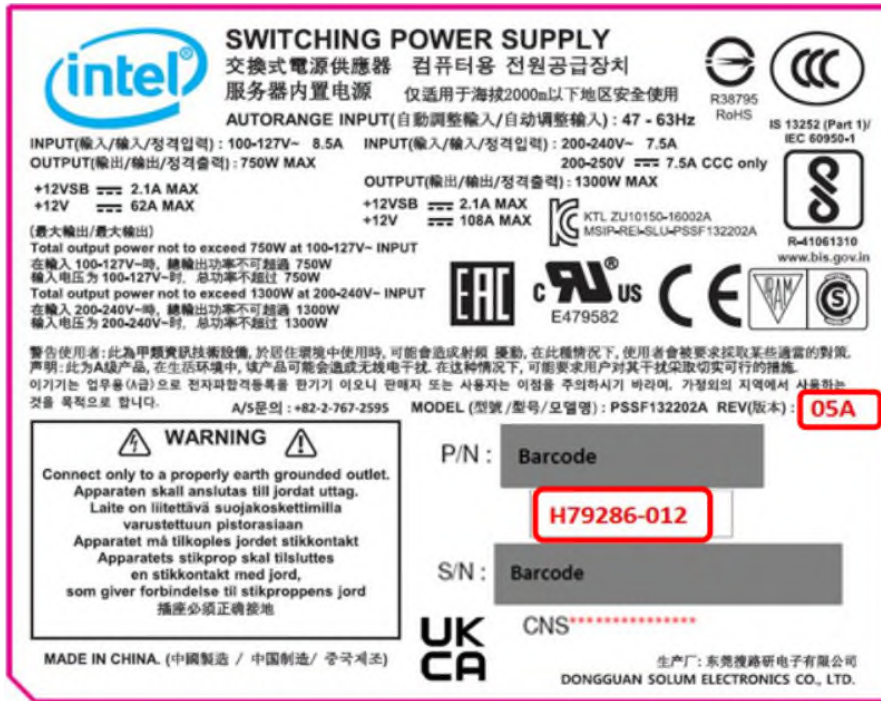
Intel is implementing the following change on the items listed in the "Products Affected" table.
