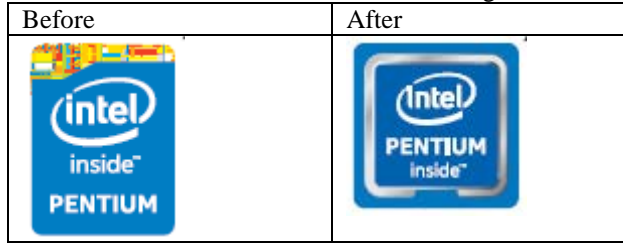
Description of Change to the Customer:

The Intel® NUC Kit SKU listed in the products affected table below will have the following changes.

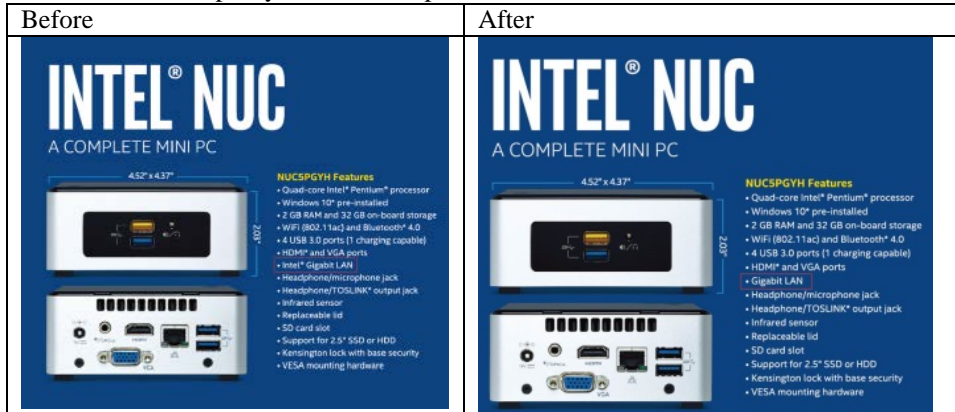
1. The BIOS will be updated from PYBSWCEL.86A.0043 to PYBSWCEL.86A.0054. To access the release notes or get a copy of the BIOS for evaluation, go to <http://downloadcenter.intel.com>.
2. The Operating System image will be updated to Windows 10* Home RS1 (version 1607).
3. The Serbia logo will be removed from the rating label.



4. The Intel® Pentium® CPU label will be changed to a new version.



5. The artwork on the pretty box will be updated.



6. The BIS laser cutting logo will be added to the adapter.



7. The Integration Guide will be updated.

Customer Impact of Change and Recommended Action:

It is recommended that customers evaluate this new BIOS to ensure a smooth transition. This change has been thoroughly evaluated to ensure that there are no quality or reliability implications to our customers. Intel validation of a new board revision does not include testing with older versions of BIOS.

The changes to the box and labels are visual only and do not affect the functionality of the product. Customers should be aware of these changes. Customers may see mixed inventory.

Intel will attempt to deplete pre-conversion material before shipping post-conversion material but there is a possibility of Intel shipping mixed inventory. Therefore, customers will need to manage and migrate to the post-conversion material as soon as possible.
