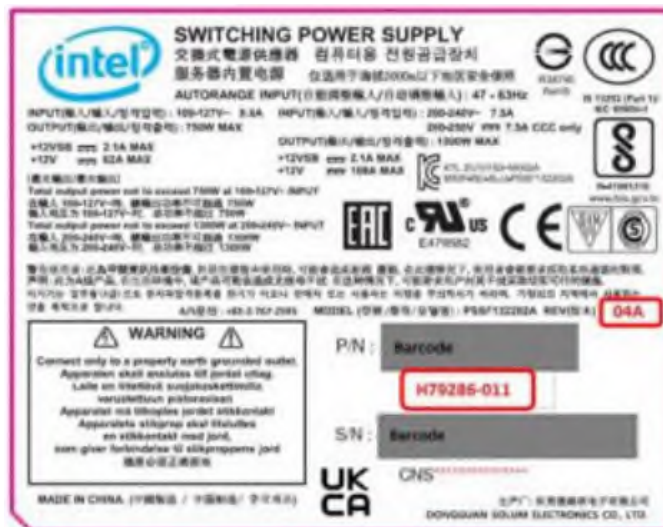

## Description of Change to the Customer:

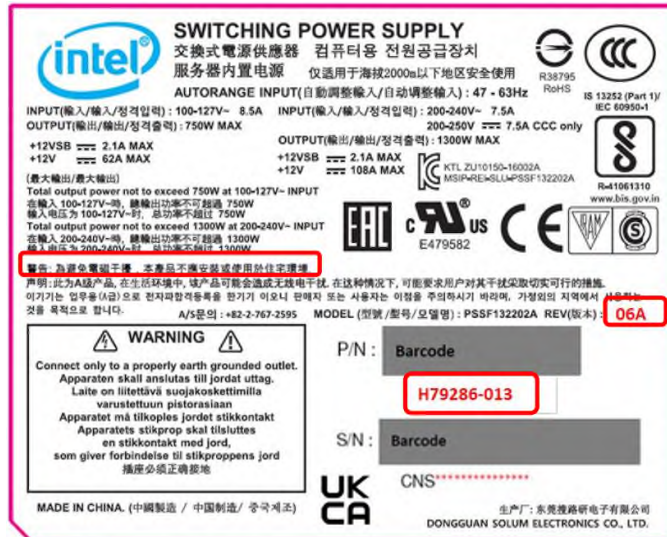
Intel is implementing the following changes on the items listed in the “Products Affected” table:

Addition of updated AXX1300TCRPS 1300W Power supply to the R1304WFTZSR SKU. The AXX1300TCRPS 1300W Power supply is changing from H79286-011 to H79286-013 due to a label update to incorporate the new Taiwan BSMI standards CNS15936 (CISPR32) and CNS15598-1 (IEC62368-1). The new BSMI standard has updated warning text that goes into effect January 1, 2024. Additional changes include a PSU firmware upgrade from 26.5.128 to 30.5.128 and a revision change from 04A to 06A. There is no impact to functionality.
