
Product Regulatory and Compliance Label Change Details:

The Regulatory and Compliance Label of the listed spine and leaf products were updated to reflect the registrations and certificates acquired for the Intel branding change.



Compliance Label Changes are:

2. Intel address was added per CE requirements
3. NRTL symbol was updated to reflect a TUV corporate brand change to TUV SUD
