## Description of Change to the Customer:

The Intel SKU listed in the products affected table will have the following changes:

The AXX1300TCRPS 1300W Power supply is changing from H79286-012 to H79286-013 due to a label update to incorporate the new Taiwan BSMI standards CNS15936 (CISPR32) and CNS15598-1 (IEC62368-1). The new BSMI standard has updated warning text that goes into effect January 1, 2024. Additional changes include a PSU firmware upgrade from 29.5.128 to 30.5.128 and a revision change from 05A to 06A. There is no impact to functionality.
