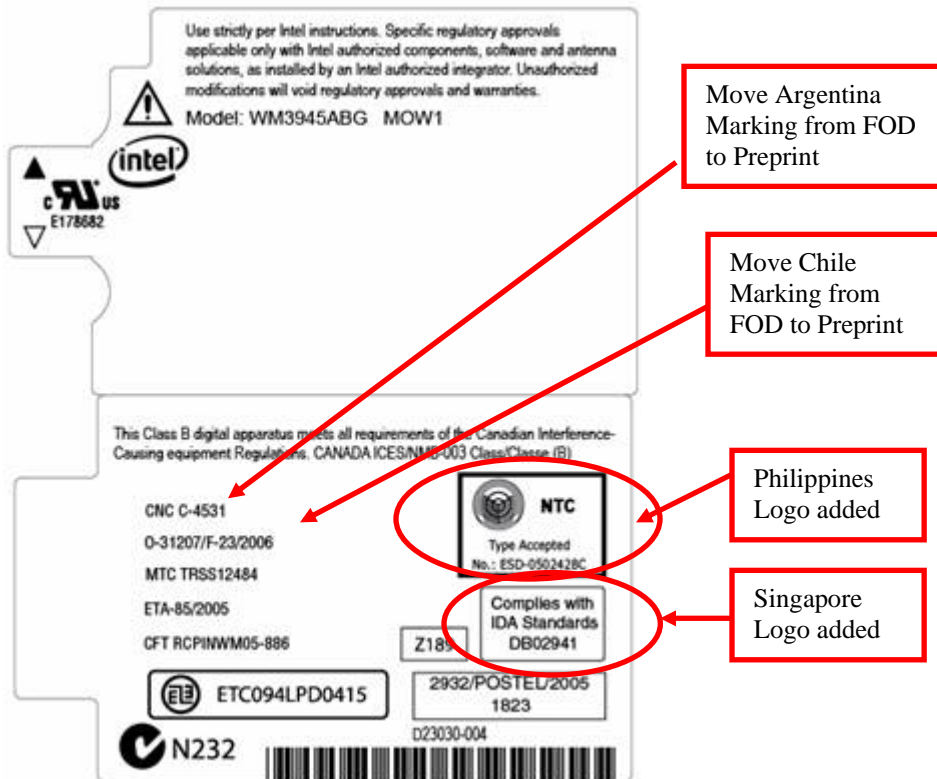
The following changes will be implemented during this ECO cycle:

The change is required to continue to provide 3945ABG supply to Intel's customers. All Intel® PRO/Wireless 3945ABG Network Connection skus will be updated with the new OUI numbers.

2. Regulatory marking changes on the M1GEN product label
  - Add Regulatory Markings for Philippines and Singapore
  - Move the Chile and Argentina regulatory markings from FOD print to Pre-print label.
