Image 1. Power supply label before the change

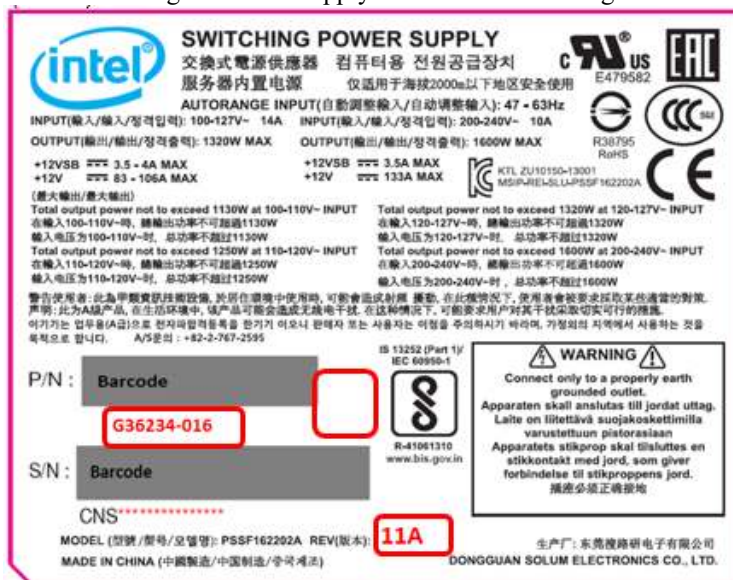
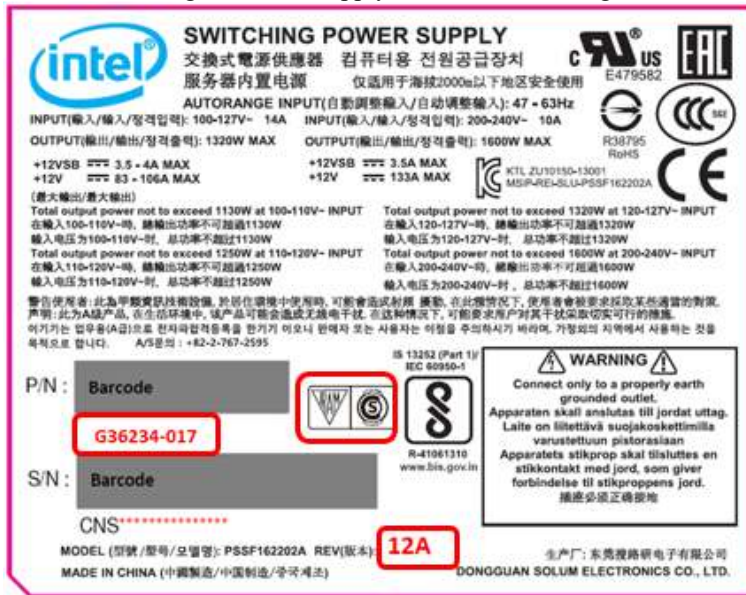


Image 2. Power supply label after the change
