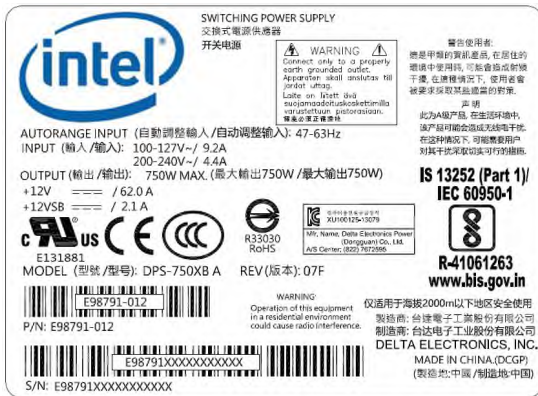


Figure #1. Label pre-change

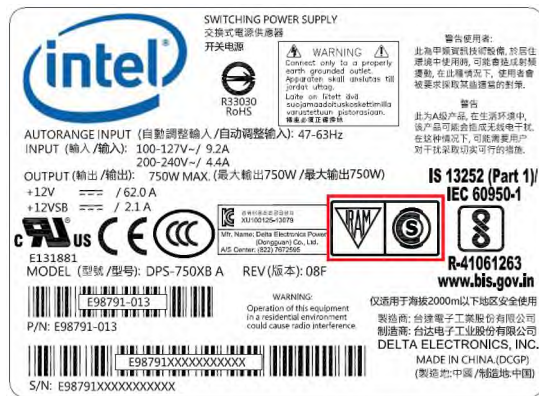


Figure #2. Label post-change
