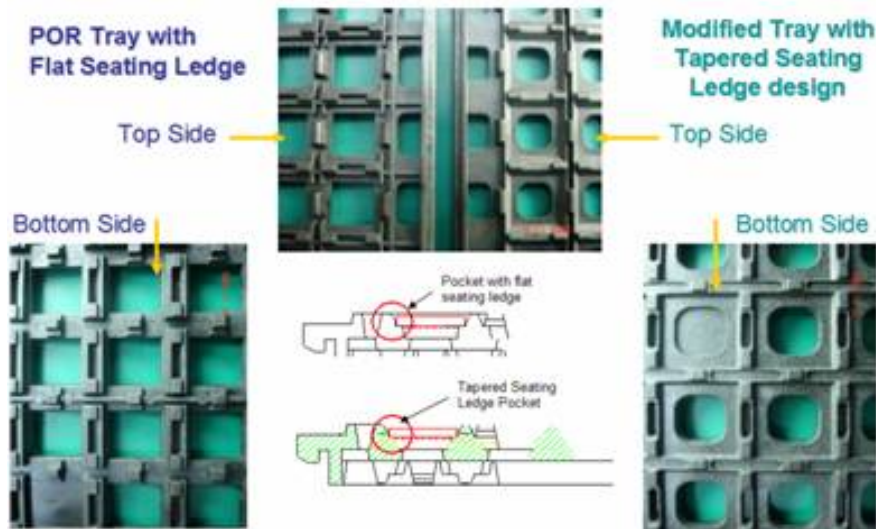
Description of Change to the Customer:

Intel will be implementing a new 14x14mm JEDEC tray pocket design to minimize the chance of trace cracking during shipment. A new tapered seating pocket replaces the existing flat seating pocket.

All Intel® PXA271 and PXA272 Processor Family products (FS-CSP) will ship in the new tapered seating pocket tray.

Customer Impact of Change and Recommended Action:

Post conversion material (redesigned taper seating pocket trays) is not compatible with pre-conversion material (flat seating pocket trays), i.e. the old & new trays are not stackable to prevent mixing.

This change does not impact Customer's equipment set-ups or overall material processing. There is no change to the total number of pieces each tray can hold, or to the number of trays each shipping container (packaging) can hold.
