## Description of Change to the Customer:

The Intel® SKUs listed in the products affected table below will have the following change(s):

- Adding the following alternate PBA: H88382-501. This alternate HSBP PBA includes the second source for the Voltage Regulator (VR) controller and the interposer PCB supporting a new Programmable System-On Chip (PSOC). For business continuity, demand fulfillment, and to minimize customer impact, an interposer PCB supporting the new component was used. The new component has passed all functional and electrical validation tests successfully.

As a result, products listed in the "Products Affected" table could be delivered to customers with any of the PBA codes of the hot swap backplanes listed under "Post Change PBA" in the table.
