Description of Change to the Customer:

Intel has qualified a second vendor of the SATA cable to be included with the Intel® Workstation board WX58BPR. This second source vendor will be added to the Intel Approved Manufacturer List (AML) so either SATA cable may be shipped with the above product. The SATA cable from the second vendor looks nearly identical to the parts from the original vendor on the Intel Approved Manufacturer List. There may be texture and color differences with parts from the second source vendor, but the parts are fit & function equivalent. Intel does not expect any impact to the customers that receive the SATA cable from the second source vendor.
