Reason for Revision: Dash-Up Current AA#

The PCB is being changed to provide additional margin for the VR (voltage regulator) when exceeding the VR temperatures under stress conditions.

Customer Impact of Change and Recommended Action:

This change has been thoroughly evaluated to ensure there is no quality, reliability, or functional implication to our customers. Intel is not recommending additional qualification of these changes on platforms received from Intel.

Intel will attempt to deplete pre-conversion material before shipping post-conversion material but there is a possibility of Intel shipping mixed inventory. Therefore, customers will need to manage and migrate to the post-conversion material as soon as possible.
